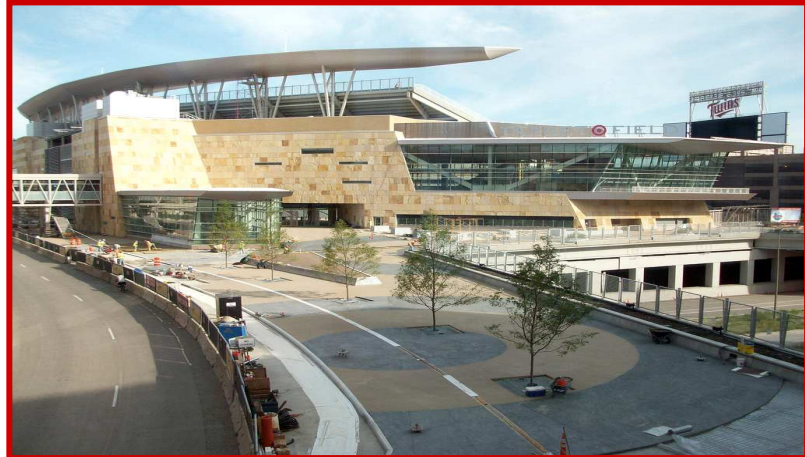

Tour the New Target Field “Twins” Stadium

April 26, 2010 - 10:00 am—2:00 pm

Thursday, August 30, 2007 will forever be remembered as the day outdoor Major League Baseball returned to Minnesota and Twins Territory, as the Twins officially broke ground at the new ballpark site in Minneapolis. Approximately 36 months later, the construction is complete and we are all anxiously awaiting our chance to see what is being billed as one of the most unique, spectacular parks in all of Major League Baseball & will mark the Twins’ 50th season of playing baseball in the upper Midwest.

- The exterior features Minnesota-native limestone and echoes the look of natural stone formations with gaps or fissure in the stone massing and ledges. These ledges or steps provide distinctive viewing sections The ballpark is designed to be a celebration of Minnesota’s natural beauty.
- The tour will take you through the stadium where you’ll be able to see the Lobby, the Suites, the Club Rooms, Locker Rooms, and meaningful moments all around the stadium, featuring “knothole” events.
- The ballpark is crowned with a canopy designed to celebrate sunny days and starlit nights and shelters the game and fans from unseasonable weather, also offering a magnificent view of the Minneapolis skyline.
- After the tour, we will have a Classic “Tailgate” Buffet and listen to guest speaker, Paul Johnson of the Twins Project Management Team.
